In addition, Stormshield is the only firewall publisher to have obtained both the Spanish "Producto CCN Aprobado" and "Producto CCN Cualificado" qualifications from the CCN (Centro Criptológico Nacional - National Cryptology Centre) for its Stormshield Network Security solutions.

Thanks to these certifications and the opening of its Madrid office, coupled with its business and marketing forces, Stormshield has a strong presence and a well-developed Spanish customer base that TheGreenBow will be able to benefit from.
